MINUTES OF THE REGULAR MEETING OF THE GOVERNING BOARD

April 26, 2005

CALL TO ORDER / OPEN SESSION

Public Comments

Mr. Eliseo Gamino introduced Ms. Ana Espinoza, the new advising specialist for the CAMP program at North District Center, Firebaugh. Ms. Espinoza addressed the Board and explained her background. She stated that she is happy to be working with students.

President McKean questioned our involvement with Dos Palos. Mr. Gamino stated that we go to Dos Palos when we are invited.

Mr. Gamino reported that a mural dedication will be occurring on May 13th and that he will provide further details as the date approaches.

Ms. Patty Scroggins, Director of Child Care Centers for the West Hills Community College District, introduced Ms. Olivia Ibanez, Site Supervisor at the child development center in Firebaugh. Ms. Scroggins presented a photo board to Ms. Ibanez and congratulated the child development center on their accreditation. Ms. Ibanez thanked everyone for their support.

REPORTS FROM ORGANIZATIONS / COLLEGES / DISTRICT OFFICE

<u>Academic Senate Report</u> – In the absence of Mr. Marlon Hall, Academic Senate President at West Hills College Coalinga, Ms. Anita Whitehead reported. She reported that the students are excited to see the Board of Trustees in Firebaugh. She stated that the Academic Senate has been busy and has had meetings discussing the needs of the students. Ms. Whitehead distributed resolutions from the West Hills College Coalinga Academic Senate. The resolutions read as follows: (typed as submitted)

West Hills College Coalinga/NDC Academic Senate Resolution-

Whereas, it has been six months since the death of Norine Oliver, the sole full-time History and Political Science instructor at West Hills College Coalinga;

Whereas, Norine Oliver taught at West Hills College Coalinga for more than twenty years;

Whereas, there is not currently a full-time History and Political Science instructor at West Hills College Coalinga;

Whereas History and Political Science are absolutely necessary for our students to graduate and transfer via approved CVHEC and other articulation agreements;

Whereas, the West Hills College Coalinga, Instructional Service Council has identified this as one of the positions needed to be hired;

the College Consultation Council has reviewed this and agreed with the Instructional Services Council;

the Presidents of WHCC and WHCL negotiated and placed this position as the top of the priority listing for faculty replacement hiring;

the Presidents of WHCC and WHCL presented this list to the Chancellor on February 16, 2005.

Whereas, it is in the best interest of students at West Hills College Coalinga to hire a full-time History and Political Science instructor;

Be it resolved, the West Hills Community College District will immediately commence hiring a full-time instructor to teach History and Political Science at West Hills College Coalinga.

West Hills College Coalinga/NDC Academic Senate Resolution-

Whereas, there has been one temporary full-time English instructor at the West Hills College Coalinga for the 2004-2005 school year.

Whereas, the temporary instructor has taught a full load this academic year and there are still more courses needing to be taught;

Whereas, the temporary instructor is the only full-time English instructor at West Hills College Coalinga;

Whereas, English courses are absolutely vital for our students to graduate and to transfer via approved CVHEC and other articulation agreements;

Whereas, the West Hills College Coalinga, Instructional Service Council has identified this as one of the positions needed to be hired;

the College Consultation Council has reviewed this and agreed with the Instructional Services Council;

the Presidents of WHCC and WHCL negotiated and placed this position as the top of the priority listing for faculty hiring;

the Presidents of WHCC and WHCL presented this list to the Chancellor on February 16, 2005.

Whereas, it is in the best interest of students at West Hills College Coalinga to hire a full-time English instructor;

Be it resolved the West Hills Community College District will immediately commence hiring a full-time instructor to teach English at West Hills College Coalinga.

West Hills College Coalinga/NDC Academic Senate Resolution

WHEREAS, West Hills College Coalinga is currently the accredited college in the West Hills Community College District and;

WHEREAS, it is fitting that West Hills College Coalinga maintain a standard of academic excellence and:

WHEREAS; it is of paramount importance to the students and the community that the college uphold its mission statement to provide both the quality and quantity of courses necessary to remain a competitive institution of higher learning;

BE IT RESOLVED, that the Academic Senate of West Hills College Coalinga is committed to having a minimum one full-time permanent instructor in each academic discipline offered by the college, for example History, English, Art, Sociology, Geology.

Ms. Whitehead commented on losing full time instructors and stated that the Senate would like to have one full time permanent instructor in each academic discipline offered by the college. They are concerned that there are not full time instructors. The Senate agrees that having a full time instructor is beneficial to the students and the academic integrity of the college.

Mr. David Rengh, Academic Senate President for West Hills College Lemoore, reported that the Senate is doing very well. He reported that West Hills College Lemoore will have their first graduation in May and it looks like they will have about 155 students walk the line. Mr. Rengh reported that Assemblymember Nicole Parra will be in attendance and the event should be a big media blitz. The Senate is working on academic policy and procedure. He stated that the biggest problem is that we have a policy in place but no procedure. Mr. Rengh reported that Ron Mitchell and Fred Mahoney are retiring this year. The Senate is excited about faculty from Coalinga participating in the graduation ceremony for Lemoore. He stated that the adjunct faculty will also walk.

Mr. Rengh provided an accreditation report for West Hills College Lemoore. He reported that surveys were distributed and information has been compiled. They are still in the process of compiling information from student surveys and things are going well. The tri chairs are meeting on a weekly basis with the standard teams and they should have a rough draft by the end of the semester. A review copy for the Board should be ready sometime during the fall semester.

<u>WHCFA Report</u> - Mr. John Bart, WHCFA President, was not present to report at this time.

<u>CSEA Report</u> - Mr. Tony Garcia, CSEA President, was not present to report at this time.

ASB Report - Mr. Willie Lee, Student Trustee, was not present to report at this time.

West Hills College Coalinga and North District Center, Firebaugh – Dr. Anthony Tricoli, President, distributed a campus activities report and briefly commented on recent and upcoming events. Dr. Tricoli commented on the benefits of the President's Scholars Program being offered to educational institutions that do not have a CSF program (i.e. Pleasant Valley Day School). He stated that we do not want to deprive them the opportunity. Dr. Tricoli reported that he has received the draft response from the accreditation team and that there were no real surprises. He now has the responsibility to review the document for errors of fact. He will be collaborating with Dr. Beverly Smith and Dr. Frank Gornick and will provide a response by the end of next week. Dr. Tricoli reported that he met with Ms. Cynthia Davis and Mr. Tom Voss to discuss the psychiatric technician program. Coalinga State Hospital has agreed to provide two faculty for us. Dr. Tricoli reported that two individuals have been selected as alumni of the year. The formal dedication of the library was held on April 22nd and

had a great turnout. Dr. Tricoli also commented on a visit to Tranquillity High School; heavy equipment class; recent theater performances; Hospital Peace Officer Training program; and scholar athlete awards.

Trustee Levinson questioned the Academic Senate resolutions. Dr. Tricoli stated he had met with Senate and didn't feel they should be brought forward because the Board of Trustees was already aware of the issue.

Dr. Gornick commented that the accreditation and the resolutions are two distinct matters.

<u>West Hills College Lemoore</u> – Mr. Don Warkentin, Interim President, distributed a campus activities report and briefly commented on recent and upcoming events. Mr. Warkentin reported on numerous items including the recent progressive dinner; SIFE student activities; Radiologic Technician program; men's golf team; outreach efforts by counselors and advisors; graduation plans; accreditation; and construction progress.

Trustee Minnite questioned enrollment. It was reported that we are at 3,400 for the spring semester and are anticipating 3,500 - 3,600 for the fall semester. Full time faculty were discussed and it was stated that 31 of the 81 full time faculty are in Lemoore. They rely heavily on adjunct faculty.

Trustee Minnite questioned enrollment for Coalinga. Dr. Smith commented that enrollment is approximately 1,200 in Coalinga and 500 in Firebaugh for the spring semester. Dr. Tricoli stated that we will see the highest enrollment ever at West Hills College Coalinga in the fall. Trustee Minnite questioned Dr. Gornick regarding the state's funding and our position. Dr. Gornick stated that he has had a lot of discussion with the Presidents and it is prudent not to make a decision until May 15th which is the date for the May revise. He stated that the Presidents are aware of this and have a strategy for employing full time faculty. Dr. Gornick commented that he feels confident in terms of their approach to doing that. We are planning on more students and betting that there will be more money and more growth.

Mr. Rengh commented that we are not at a standstill and are hiring three faculty at this time in art, sociology and history.

Mr. Warkentin reported that West Hills College Lemoore will be co-hosting a simulcast event on April 29th, The Influential Leader. He also reported that the middle college high school grant application has been submitted and we are waiting to hear the outcome.

<u>Chancellor's Report</u> – Dr. Gornick thanked Dr. Tricoli and his staff for a great dedication event at the library. He expressed his congratulations to Ms. Scroggins and the child development center staff for their accreditation. Dr. Gornick also expressed

his congratulations to Mr. Warkentin for a successful progressive dinner event. In closing, Dr. Gornick commented on the recent AACC convention he attended in Boston with two of the Board members and the IEE President's meeting held during the convention.

CHANCELLOR'S OFFICE

- O-21 Board of Trustees Meeting Schedule Trustee Minnite requested that all of the early meetings be moved to a 3:00 p.m. start time. Trustee Levinson stated that he would not want to change the start time of 10:00 a.m. for the annual meeting in Firebaugh. President McKean asked that the Chancellor's Office review the schedule again and bring the schedule back to the next meeting for consideration.
- CO-22 Board Policy 7105, Statement of Ethics Mr. Rengh commented on the proposed policy and stated that the items listed are not measurable. Trustee Ivans commented that this is an important policy to have in place. Mr. Rengh provided comments on the policy from the faculty association and the Academic Senates and distributed copies to the Board. President McKean stated that this policy is presented for a first reading at this time.

Trustee Levinson requested that the Academic Senate come back during a specified period of time with what they would like to change in the policy. Dr. Gornick stated this may cause some consternation with the process and what the President's have to deal with. He further explained that the policy was reviewed by the Executive Cabinet and then sent to the

campuses for their review and approval. The policy was approved at the campus level by the District Council on Student Learning (DCSL) with recommendations, all of which were included in the policy presented to the Board today. Dr. Gornick reported that the DCSL's membership has representation from both the faculty association and the Academic Senate and they were provided the opportunity to vote on this policy at the DCSL level.

This item was presented for a first reading at this time. Approval will be requested at a later date.

CO-23 Administrative Procedure 2745, Board Self-Evaluation – Trustee Levinson commented that he has a problem with question 18 on the self evaluation form. He questioned the solution if there is a negative response. Dr. Gornick commented that the question is too ambiguous and brief discussion occurred.

Trustee Oxborrow made a motion to table the item at this time until additional information is provided. Trustee Ivans seconded the motion. Trustee Levinson stated that although the Board of Trustees had a first reading on this procedure in February, it needs to be reviewed further before final approval. The motion to table the item carried unanimously.

Mr. Rengh thanked the Board of Trustees for their approval of the faculty tenure recommendations.

At this time Trustee Minnite left the meeting.

- FS-41 <u>Fiscal Services Report</u> Mr. Ken Stoppenbrink distributed the budget status report and briefly discussed the status of the budget expenses and revenues.
- FS-42 Changes to Adopted Budget The changes to the 2004-2005 adopted budget were approved on a motion by Trustee Levinson, seconded by Trustee Ivans, and carried unanimously.
- **FS-43** Change Orders The following change orders were approved on a motion by Trustee Cantu, seconded by Trustee Ivans, and carried unanimously:

The contract between the West Hills Community College District and the Coalinga State Hospital, with the modification as noted by Mr. Stoppenbrink, was approved on a motion by Trustee Levinson, seconded by Trustee Ivans, and carried unanimously.

Trustee Oxborrow commented that it is great to be in Firebaugh and see the campus.

Trustee Cantu commented that it is good to be in Firebaugh and great to see the city manager be active with the college. Trustee Cantu thanked Ms. Ibanez for the great job she is doing with the child development center.

Trustee Ivans thanked everyone for the reports. She stated that the library in Coalinga looks great. Trustee Ivans expressed her congratulations to the newly tenured faculty.

Trustee Levinson echoed the comments made by his fellow Board members. He thanked Mr. Warkentin for his efforts at the progressive dinner event. He stated that it was nice to attend the dedication event at the library in Coalinga and see the campus. Trustee Levinson briefly reported on his trip to Boston with Trustee Henry and Dr. Gornick. He stated that the trip was educational. Trustee Levinson congratulated Edna Ivans for her longevity as a trustee and mentioned the upcoming awards brunch at which Trustee Ivans will be honored.

President McKean expressed his congratulations to Trustee Ivans and stated that he appreciates her many years of dedicated service. He commented on the enjoyable library dedication event and stated that the entire campus looks very nice and that it is good to see all of the community members on campus.

President McKean announced that the next meeting of the Governing Board is scheduled for May 17, 2005.
