## REPORTS FROM ORGANIZATIONS / COLLEGES / DISTRICT OFFICE

<u>Academic Senate Report</u> – Mr. Jeff Wanderer, Academic Senate President for West Hills College Coalinga, was not present to report at this time.

Mr. Kurt Sterling, Academic Senate President for West Hills College Lemoore, reported that the Senate has been working on writing sessions for Board Policy and Administrative Procedure 7215, Faculty Responsibilities. They are also working on the program discontinuance policy and Board Policy 7211, Faculty Service Areas, Minimum Qualifications, and Equivalencies.

<u>WHCFA Report</u> – Mr. Ken Sowden, WHCFA President, reported that negotiations were held on Friday, September 14. Not a lot of progress was made and the team was disappointed. Another session is scheduled for October 19 and he thinks a lot more progress will be made. He stated that negotiations are always a difficult process. Mr. Sowden reported that Dr. Martha Rodriguez, counselor, passed away on August 31.

<u>CSEA Report</u> – Mr. Keith Brock, CSEA President, reported that Mr. John Ieronimo is now serving as first vice president.

West Hills College Coalinga and North District Center, Firebaugh – Dr. Tom Harris, Interim President, reported that he recently had a good experience visiting the Mendota School District. He was able to see the Westside Institute of Technology (WIT) building, and see an ROP class in action. He also met with the Superintendent and Principal of Mendota High School. We are looking at the possibilities for the bond money that is earmarked for that area. Dr. Harris reported that the football team is in distress; however, they have a lot of talent and are not giving up.

Ms. Stephanie Droker, Vice President of Educational Services, reported that Ms. Raquel Rodriguez, Associate Dean of Student Learning, is currently in Sweden on a recruiting trip. She expressed her thanks to the faculty for participating in the C6 grant through the Department of Labor. A very invigorating convergence of faculty from all of the regions met together to work on the grant. Ms. Droker reported that West Hills College Coalinga hopes to be able to offer a dinner theater very soon.

Mr. Mark Gritton, Associate Dean of Student Services, reported that a 9/11 event was held on campus last week. Staff are currently looking at judicial modules to govern the residence halls with topics including academic integrity, cleanliness, and successfully living with a roommate.

Dr. Marcel Hetu reported on an open house recently attended by UC Davis for the nutrition and obesity project in Firebaugh. He also briefly commented on the 9/11 event at the North District Center, Firebaugh.

Mr. Richard Larson reported on the Farm of the Future, stating that staff are continuing to move to the new facilities. The new classrooms are being used and there is quite a bit of painting occurring. 13 students are completing the ag maintenance mechanic certificate. The almond yield was down this year and the pistachio yield is similar to last year.

West Hills College Lemoore – Mr. Don Warkentin, President, thanked the students for being in attendance at the meeting. West Hills College Lemoore has been busy with the opening of school. He introduced Ms. Angela Tos, who is serving as the administrative intern for 2012-2013 in student services. Mr. Warkentin reported that accreditation midterm report activities are beginning and the first meeting will be held this Friday.

Ms. Dorsey-Robinson Sylvia reported on student services activities. She stated that the summer bridge program was successful and discussed the career center. Mr. Warkentin reported that the athletic program is off to a good start.

<u>Student Trustee Report</u> – Ms. Britanny Burkhart, Student Trustee, reported that West Hills College Lemoore has elected two presidents and two vice presidents. She briefly reported on the 9/11 event, stating that it was a very moving ceremony. The English lab has been turned into an ACE lab – Academic Center for Excellence.

<u>Chancellor's Report</u> – Dr. Frank Gornick, Chancellor, expressed his thanks to West Hills College Lemoore for hosting the Board meeting. He passed around a magazine which features an article on the West Hills College Coalinga heavy equipment class. He also passed around correspondence from students at Coalinga Huron Avenal House. Dr. Gornick reported that he gave a tour of the new ag facilities last week in Coalinga to some interested parties. There are a lot of good things happening at the farm.

  Fiscal Services Report Mr. Stoppenbrink provided the fiscal services report. He reported that the district is 16% through the fiscal year. General fund 11 revenues are at 4.3% and general fund 11 expenditures are at 14.9%. General fund 12 revenues are at 1.2% and general fund 12 expenditures are at 7.3%.

  Contract Award North District Center, Firebaugh Site Improvements

  Project On a motion by Trustee Cantu, seconded by Trustee Ivans, and carried unanimously, the contract for the North District Center, Firebaugh Site Improvements project was awarded to Hobb's Construction for a total bid of \$174,826.

  Contract Award West Hills College Coalinga Farm Office Relocatables

  Project Trustee Cantu questioned the age of the relocatable units, stating that the cost is high to relocate old buildings. Mr. Stoppenbrink stated that the district already owns the buildings and the cost is for the infrastructure. Brief discussion took place regarding where the building will be placed. Ms. Celina Garcia, AP Architects, responded that they will be located near the 500 building.

On a motion by Trustee Ivans, seconded by Trustee Oxborrow, and carried unanimously, the contract for the West Hills College Coalinga Farm Office Relocatables project was awarded to MARKO Construction Group, Inc. for a total bid of \$238,000.
