Priority Registration

The key elements for eligibility of priority registration stands by fulfilling certain academic requirements:

- ✓ Application for admission to WHCL
- ✓ High School and/or Official College Transcripts
- ✓ Veteran Orientation Workshop
- ✓ Complete an Student Educational Plan with veteran counselor/advisor

Appeal of Loss of Enrollment Priority

✓ Students may appeal the loss of enrollment priority when the loss is due to extenuating circumstances. Extending circumstances are documented, verified cases of accidents, illnesses or other circumstances beyond the student's control or when a student with a disability applied for, but did not receive reasonable accommodation in a timely manner. These circumstances may involve active duty military services, including active duty for training. The VA department requires documentary evidence in support of statements (WHCL catalog p. 18).
